COURSE: NUR 121, Certified Nursing/Geriatric Assistant, Fall 2015 Letter of Recognition, 7 Credits

COURSE DESCRIPTION:

This course prepares the student to effectively implement the nursing care plan for client populations with health alterations while utilizing professional standards of practice. Content includes disease processes, systems review, nutrition, and infection control. Community facilities provide settings for clinical experience that is focused on skill competencies. Laboratory fee required. Total of 70 hours of lecture, 30 hours of laboratory and 60 hours of clinical.

STUDENT LEARNING OUTCOMES:

Total Hours of Coursework:

To earn one academic credit at HCC, students are required to complete a minimum of 37.5 clock hours (45 fifty-minute "academic" hours) of coursework per semester. Those hours of coursework may be completed through a combination of hours within the classroom and hours outside the classroom. Certain courses may require more than the 37.5 minimum hours of coursework per credit.

For most classes in this course, students should expect to do at least 2 hours of coursework outside of class for each hour of in-class coursework.

COURSE CONTENT OBJECTIVES:

The course topical outline will be provided at orientation as a separate handout.

ASSESSMENT PROCEDURES:

Overall Grade

The overall grade for the course will be based upon the **successful completion of the (6) six course components** at a satisfactory level of performance:

- 1. Theory Component (70 hours),
- 2. Lab Component (30 hours), project,
- 3. Clinical Component (60 hours) experience and competency evaluation
- 4. Competency Evaluation for CNA Component 5 skills /25 minutes
- 5. Attendance Component
- 6. Project Component

Students must achieve an 80% average in the theory component of the course, pass the lab component, pass the clinical component attendance, project, and pass the competency evaluation for successful completion, If a student does not achieve an 80% in theory, pass the lab, pass the clinical, or pass the competency evaluation then the student will receive a failing grade for the course.

Theory

The student's theoretical knowledge will be evaluated in 6 written exams throughout the course and one comprehensive final exam. The student must achieve an 80% in order to pass the course. The exams are weighted as follows:

Lab

Skill competency will be graded in the lab as Pass or Fail. Students must show competency in the following skills and have all skills signed off by the instructor in order to receive a Pass grade:

- Washes Hands
- Assists client to ambulate
- Assists client with use of bedpan
- Cleans and stores dentures
- Counts and records radial pulse
- Counts and records respirations
- Dresses client with affected (weak) right arm •
- Feeds client who cannot feel self •
- Gives modified bed bath (face and one arm, hand and underarm) •
- Measures and records blood pressure •
- Measures and records urinary output •
- Measures and records weight of ambulatory client •
- Performs passive range of motion (ROM) for one knee and one ankle •
- Performs passive range of motion (ROM) for one shoulder •
- Positions client on side •
- Provides foot care on one foot •
- Provides mouth care •
- Provides perineal care (Peri-care) for incontinent client
- Puts one knee-high elastic stocking on client •
- Transfers client from bed to wheelchair •

Clinical

Clinical performance will be graded as Pass or Fail. Students must pass the clinical component in order to pass the course. The student's clinical skills knowledge will be evaluated on the following criteria:

- Uniform per dress code
- Arrives promptly
- Arrives prepared
- Displays positive interpersonal Skills
- Maintains universal precautions
- Uses Safety measures
- Receptive to instruction
- Team player
- Able to work independently
- Professional interactions with patients
- Professional interactions with facility staff
- Uses communication skills
- Finished assigned tasks
- Self-motivated
- Flexible in tasks

Competency Evaluation

Competency evaluations will be graded overall as Pass or Fail. Students will perform five of the NNAAP Skills according the <u>Maryland Geriatric Nursing Assistant Candidate Handbook</u> (2014) within twenty-five minutes. Each skill must be passed with at least 80% accuracy in order to receive a passing grade. If a student does not perform each skill with at least 80% accuracy the student will receive a failing grade for the course. Competency evaluations will be performed on five of the possible twenty-two following skills:

- Washes Hands
- Assists client to ambulate
- Assists client with use of bedpan
- Cleans and stores dentures
- Counts and records radial pulse
- Counts and records respirations
- Dresses client with affected (weak) right arm
- Feeds client who cannot feel self
- Gives modified bed bath (face and one arm, hand and underarm)
- Measures and records blood pressure
- Measures and records urinary output
- Measures and records weight of ambulatory client
- Performs passive range of motion (ROM) for one knee and one ankle
- Performs passive range of motion (ROM) for one shoulder

- Positions client on side
- Provides foot care on one foot
- Provides mouth care
- Provides perineal care (Peri-care) for incontinent client
- Puts one knee-high elastic stocking on client
- Transfers client from bed to wheelchair
