- Demonstrate and understanding of birth control, pregnancy, parenting, and family planning.
- Research, analyze, and reflect on commonly reviewed human sexuality topics including gender roles, social issues, sexual identity, and relationship behavior.

- Students will attain 70 percent proficiency on a written exam and reaction essay covering sexual anatomy, function, and development throughout human lifespan
- Students will perform at 70 percent proficiency on a written exam and reaction essay covering social cultural and religious influences on the formation of individual sexual attitudes and values.
- Students will perform at 70 percent proficiency on a written exam and reaction essay covering birth control, pregnancy, parenting, and family planning.
- Students will utilize MLA format and demonstrate correct citations based on the Humanities scoring rubric, and score 70% or above on a research PowerPoint project regarding a human sexuality topic.

- Collect data as to the percentage of students who are successful in meeting those standards at a 70 percent proficiency.
- Number of students who correctly utilize MLA manuscript format (cross-disciplinary connections).
