COURSE DESCRIPTION:

From the catalog: This course prepares students for professional commercial use of their art: commercial portraits, environmental portraits (events), street, a day in a life, American family. Students participate in events of choice and group field trips to selected photo opportunities, public events and celebrations. SLR Digital Camera recommended. Students produce a portfolio. Course fee required. Total of 60 hours of lecture. **PRE-REQ: ART 115 OR PORTFOLIO REVIEW.**

STUDENT LEARNING OUTCOMES

- 1. Student recognizes and applies the fundamental elements of art in a visual assignment.
- 2. Student uses proper language, tools and techniques of the medium.
- 3. Student recognizes and differentiates the styles and medium of important artists.
- 4. Student experiences creative challenges that develop critical thinking and problem solving.

COURSE CONTENT OBJECTIVES

- 1. Knowledge of significant historical artist and works in the medium of environmental portraits, event photography, street photography and American Life.
- 2. Knowledge of the way photographs are made in relationship to visual elements of composition.
- 3. While students are expected to visually look at all these types of photography in terms of "art", commercial application will be applied as well.
- 4. Development of a portfolio of final work that can be used for job application.
- 5. Development of a personal project for future photographing.
- 6. Student develops personal and individualized achievement of both technique and content of a visual expression in a traditional or non-tradition art form.
- 7. Student prepares to portfolio and prepares work for exhibition

TEXTBOOK

There is no textbook required for this course. The teacher will be supplying handouts and online research for information.

TOTAL HOURS OF COURSEWORK:

To earn one academic credit at HCC, students are required to complete a minimum of 37.5 clock hours (45 fifty-minute "academic" hours) of course work per semester. Those hours of coursework may be completed through a combination of hours within the classroom and hours outside the classroom. Certain courses may require more than the 37.5 minimum hours of coursework per credit. For most classes, students should expect to do at least 2 hours of coursework outside of class for each hour of inclass coursework. ***For this course students are required to attend all classes and expected to do a minimum of 6 hours of work outside of class per week.

Important material from the outside sources will be covered in class. You should plan to take careful notes as not all material can be found in the handouts. Students will be exposed to their instructor's work and experience as a photographer and from well-known working photographers in the field for inspirations. Feedback/critiquing will be an important teaching tool. On-line research and reading, visual power point lectures, and classroom direct assistance will be used to build skill levels. Students will be exposed to many Master photographers and many types of photography for inspiration. While there may be a varying level of student skills in present in the class students will be able to expand on whatever level they come into the class with.

Final Portfolio: The final portfolio of proof prints is intended to take the photograph to it's final stage and that is the print. The portfolio also gives student's the satisfaction of seeing a finish body of work and their accomplishments of the semester.

COURSE POLICIES
