- 1. Professor Stonestreet, Professor Wine, teachers from the Washington County Teaching Academy instructors, and a WCPS Teaching Academy Retiree have graded student portfolios with the assessment rubric, and compared results, in order to validate the rubric and determine its validity.
- 2. The lesson plan is graded with a rubric. The rubric has been validated by Lead Teachers from two different Title I WCPSs.

Results (What do your assessment data show? If you have not yet assessed student achievement of your learning outcomes, when is assessment planned?)

1. In the fall of 2016, students struggled with the portfolio assignment; specifically data that they have previously researched on the MSDE website relating to FARM rates in elementary schools. The reporting of this data has become difficult to interpret and does not add up to 100 percent. I have contacted four different elementary principals that I have worked closely with in the past and they are unable to explain the current MSDE data when I share it with them. Washington County does not currently have any information of this type available. I will continue to work with students to research and determine the current FARM rates.

2. The data continues to show that the changes I made to the lesson plan assignment has improved student outcome data. This year students utilized an online resource, Planbook, exposing them to a method of effective lesson planning that allows when aligning Common Core/ State standards, objectives, and assessments.

In the spring of 2016 I created a class assignment that has the students hands-on with the MSDE website, finding and analyzing data related to a Title 1 school in another county so that they have background knowledge on how to access that information before being held accountable for it in their Professional Portfolio. It improved the scores in this specific area of weakness within the portfolio, so I plan on continuing this assignment.
