# **COURSE DESCRIPTION:**

Aural Skills I – IV is a regimen of skills classes designed to increase the student's aural comprehension and musicianship skills. The courses are closely correlated to the music theory sequence (MUS 201, MUS 202, MUS 241, and MUS 242) and will help expand the student's intervallic recognition and ability to recognize rhythmic, melodic and harmonic structures and patterns in music they hear, and write these down (dictation). The courses will also introduce and expand on solfege (sight singing) and basic conducting techniques. Prerequisite: MUS 144

## **STUDENT LEARNING OUTCOMES:**

Building on MUS 144, the student will be able to:

- Demonstrate competency in general musicianship in solo and ensemble performance as well as advanced music theory.
  - Demonstrate beyond basic conducting patterns and perform a wider variety of written rhythmic patterns at sight.
  - Sing major and minor scales, intervals, triads and more complex tonal melodies using solfege and identify types of intervals triads and seventh chords by ear.
- Display aural comprehension of music.
  - Notate longer and more complex melodic and harmonic dictation exercises.

## MINIMUM CLOCK HOURS REQUIRED FOR THIS COURSE

To earn one hour of academic credit at HCC, students are required to complete a minimum of 12.5 clock hours (15 fifty-minute "academic" hours) of coursework per semester. Those hours of coursework may be completed through a combination of hours within the classroom and hours outside the classroom. Certain courses may require more than the 12.5 minimum hours of coursework per credit. A three credit hour course requires 37.5 clock hours.

For most classes, students should expect to do at least 2 hours of coursework outside of class for each hour of in-class coursework.
