### Expected Learning Outcomes

1. Demonstrate the use of terms and concepts related to government regulation and the legal environment.
2. Understand the role that government has in the legal environment and how that impacts business activity.
3. Describe and analyze the legal system in terms of where our system comes from and how it works to place boundaries around business.
4. Describe and explain important legal concepts, demonstrate the ability to apply them to new situations, and communicate solutions.
5. Discuss ethical implications of the legal environment.
6. Demonstrate how the legal environment controls activities between businesses and private citizens, between businesses and competition and between businesses and the employees who work there.

Assessment will be demonstrated for all six Expected Learning Outcomes through the use of three exams, thirteen discussion assignments, fourteen quizzes, and a term paper. Class attendance for the face-to-face classes is important and students may not exceed three absences in a semester or it impacts the final grade for the course.

**Validation** (What methods have you used or will you use to validate your assessment?)

Validation will be accomplished by measuring the six Expected Learning Outcomes through a series of questions from the three examinations in the class. It is assumed for the selected questions that the publisher validates any questions that may be used on tests and test the questions for reliability.

The data that is collected can be used to determine whether the students are achieving the expected levels of understanding relative to the learning outcomes established for the course. The collection of the data is expected to begin in Fall Semester 2016.

### **LEGAL ENVIRONMENT OF BUSINESS (BUS 104) SLOA SUMMARY – FALL 2017- SPRING 2018 EVALUATION**

In the Legal Environment of Business (BUS 104), there are six Learning Outcomes against which student performance is measured. The data collected for this course is also based on the use of a new Open Source textbook beginning in the Fall Semester 2016. All questions from the examinations were used and mapped against each of the six Learning Outcomes to determine student performance. The standard that we hope to achieve is that 80% of the students will achieve the Learning Outcome. Student performance data is also presented in terms of the results achieved by face-to-face classes versus online classes.

#### **Outcome #1: Demonstrate the use of terms and concepts related to government regulation and the legal environment**

The Spring 2018 face-to-face class performed lower than the Fall 2017 class 77% to 94% respectively while the Fall 2017 online class outperformed the Spring 2018 class 90% to 80% respectively. Overall the Fall 2017 classes outperformed the Spring 2018 classes on this standard 92% to 79%. Overall 82% of the students met this Outcome performance.

#### **Outcome #2: Understand the role of government has in the legal environment and how that impacts business activity**

The Spring 2018 face-to-face class performed lower than the Fall 2017 class 67% to 70% while the Fall 2017 online class outperformed the Spring 2018 class 76% to 69% respectively. Overall the Fall 2017 classes outperformed the Spring 2018 classes on this standard 73% to 68%. Overall 70% of students met this Outcome performance.

#### **Outcome #3: Describe and analyze the legal system in terms of where our system comes from and how it works to place boundaries around business**

The Spring 2018 face-to-face class performed lower than the Fall 2017 class 76% to 84% while the online Spring 2018 class performed lower than the Fall 2017 class 77% to 85%. Overall the Spring 2018 classes performed lower than the Fall 2017 classes on this standard 77% to 84%. Overall 80% of the students met this standard.

**Outcome #4: Describe and explain important legal concepts, demonstrate the ability to apply them to new situations, and communicate solutions**

For Outcome #4, The Fall 2017 face-to-face class outperformed the Spring 2018 classes 87% to 71% respectively. The Fall 2017 online class outperformed the Spring 2018 online class on this standard 88% to 75%. The Fall 2017 classes outperformed the Spring 2018 classes on this Outcome 87% to 73% respectively. Overall 78% of all students exceeded the standard for this Outcome.

**Outcome #5: Discuss the ethical implications of the legal environment**

For Outcome #5, the Fall 2017 face-to-face class outperformed the Spring 2018 class 67% to 55% respectively, while the Fall 2017 online class outperformed the Spring 2018 class 74% to 59%. The Fall 2017 classes overall outperformed the Spring 2018 classes for this Outcome 71% to 62%. Overall 62% of all students exceeded the standard for this Outcome.

**Outcome #6: Demonstrate how the legal environment controls activities between businesses and private citizens, between businesses and competition and between businesses and the employees who work there**

For this Outcome #6, Fall 2017 face-to-face class outperformed the Spring 2018 class 81% to 72% while the Fall 2017 online class outperformed the Spring 2018 class 82% to 73%. The Fall 2017 classes outperformed the Spring 2018 classes for this standard 82% to 76% respectively. Overall 76% of the students exceeded the standard for this Outcome.

For this course, the overall results would indicate the performance is stronger for the online classes (76%) versus the face-to-face classes (74%) for the past academic year. The overall classes exceeded the 80% on two of the six Outcomes, however face-to-face classes did exceed the standard of 80% on one Outcome (1) while the online classes exceeded performance on two Outcomes (1 and 3).

These results were obtained based our second year use of an Open Source textbook and also my second year teaching this class. While 75% of the students did exceed the standards for performance in this class, I am satisfied with this given that I am teaching this class for the second year. It is clear however that I need to work on some topics in this class with greater emphasis—particularly the role of government in the legal environment, its impacts on business, and on the ethical implications of the legal environment.
