COURSE DESCRIPTION: This course is a study of constitutional law as it has developed through interpretations of the United States Supreme Court. Subjects include the interaction and interplay of the judicial, executive, and legislative branches of the government and the powers and limitations under the US Constitution. Prerequisites: American Government, POL 101.

STUDENT LEARNING OUTCOMES: This course will assist the student to:

- A. Expand their understanding of the powers and limitations of the federal government and the meaning of civil liberties included in the Constitution.
- B. Develop a basic understanding of the federal court system and the role and powers of the United States Supreme Court.
- C. Acquire the critical skills to read, interpret, and evaluate Supreme Court opinions and decisions.
- D. Learn to think critically, learn to analyze and understand constitutional issues and concepts.

Total Hours of Coursework:

To earn one academic credit at HCC, students are required to complete a minimum of 37.5 clock hours (45 fifty-minute "academic" hours) of coursework per semester. Those hours of coursework may be completed through a combination of hours within the classroom and hours outside the classroom. Certain courses may require more than the 37.5 minimum hours of coursework per credit.

For most classes, students should expect to do at least 1 - 2 hours of coursework outside of class for each hour of in-class coursework.

COURSE CONTENT OBJECTIVES: This course will assist the student to:

- A. Understand the following principles and themes as related to constitutional law:
 - 1. Fundamental understanding of the United States Constitution
 - 2. Role of the United States Supreme Court
 - 3. Powers of Congress
 - 4. Powers of the President
 - 5. Growth of administrative agencies and the modern administrative state
 - 6. Expansion of federal power
 - 7. Presence of civil liberties in the Constitution
 - 8. Protection of property rights in the Constitution
 - 9. First Amendment: Freedom of speech and separation of church and state
 - 10. Fourth Amendment and other criminal protections
 - 11. Equal protection and due process
 - 12. Learn to read, understand, and critique Supreme Court opinions

ASSESSMENT PROCEDURES: The requirements for this course include:

- A. There will be written assignments to be completed; the papers will be due and will be discussed in the following class. For example, the written assignment handed out on January 25, 2016 must be completed and handed in at the beginning of the next scheduled class. The questions should be fully answered, exploring both sides of the question and defending a particular conclusion. APA style should be followed. A copy of the style guide is posted on the Moodle site for this class. Not following the style will negatively affect the student's grade. The papers should be at least two pages and no more than three pages. Late papers will not be accepted.
- B. Supreme Court Cases/Issues Assignments A written and oral presentation on a current constitutional issue or significant Supreme Court decision is required. Topic/issue must be approved by the Instructor. Due date for written project is April 20, 2016. In class presentations will be presented in class on April 25.
- C. Quizzes: There will be at least 10 quizzes.
- D. Participation: Students will be expected to engage in class discussion about the subject matter. Participation will be graded with each class. A grade of "Good," "Average," or "Unacceptable" will be given following each class. The points of these levels will be 100, 80, and 60 respectively.
- E. Grading: The written assignments will make up 15% of the final grade. The written project and oral presentation on a constitutional issue or Supreme Court case(s) will count as 20% of the final grade. Quizzes will count for 20% of the grade. Attendance/participation will count for 25% of the grade. The final exam will count for 20% of the grade.
