- 2. Graduate survey 18 students have completed all requirements and courses for the program and will receive their AAS degree.
- 3. Overall the Dental Hygiene Program 18 students student have completed all the program requirements/courses and one (1) student had withdrawn from the program, and 2 students were unsuccessful meeting the program requirements.
- 4. CDCA Clinical Boards all 18 students successfully passed the exam.
- 5. National Board of Dental Hygiene Exam- no data at this point in time.

**Follow-up** (How have you used or how will you use the data to improve student learning?)

Data collection and peer review by faculty and members of the Dental Hygiene program advisory board committee will determine changes necessary in program teaching strategies and techniques to ensure students are meeting the outlined learning outcomes. The curriculum is reviewed to be sure that it is following the CODA accreditation standards for Dental Hygiene education, specifically the curriculum must prepare students for practice in a variety of settings and students must acquire knowledge, skills, and abilities needed for practice and successful completion of the CDCA Clinical Board Exam, as well as the NBEDH. Areas for improvement in the curriculum include grade distribution as it is not even, most grades are in the A and B range thus no Bell Curve. An annual review of the Dental Hygiene Program Policies Manual to identify areas which are not clear, and could be interpreted incorrectly. Additionally, the data collected, along with post-graduation tracing of student success is needed for internal and external validation.

## **Budget Justification** (What resources are necessary to improve student learning?)

- Continue unit planning discussions to address the long-term sustainability of the program and all required equipment.
- Planning and replacement of old dental units, 5 per year beginning 2019-2020
- Replacement or repair of Cavitron units, only have 12 functioning in our 18 unit clinic
