Validation: (What methods have you used or will you use to validate your assessment?)

1. Students must successfully demonstrate skills learned in this course and receive a grade of 75% (C) or higher to progress in the Dental Hygiene Program

(100% (18/18) of students achieve an average of 84% or higher on all unit exams. Exam 1-84% or higher, Exam 2-85% or higher)

(100% (18/18) of students achieve an average of 75% or higher on Case studies & Homework.)

(100% (18/18) of students achieve an average of 90% or higher on the Cultural Research Paper and Presentation and 95% on the Moral Compass projects)

2. Students must successfully complete a Cultural Research Case Paper and Presentation and write a personal Moral Compass reflection paper. The intent of this project is for the students to identify and research a culture different from their own, create a group presentation which lists a minimum of <u>five</u> things a dental hygienist should understand in order to provide culturally competent care to his/her patients. An individual Moral Compass paper allows the student to explore the origin of their ethical values and compare that to the culture they have researched.
