NUR 231 NURSING CARE OF THE ACUTE AND CHRONICALLY ILL ADULT III Spring 2019

Course Description

This course is a sequence to NUR 230. Additional emphasis will be placed on preparing students to assume an even greater responsibility for organizing, managing, and delivering care to a larger group of clients with life threatening situations or complex health problems. Complex critical care concepts and advanced technical skills are introduced. Focus moves from maintenance and promotion of health to utilization or emergency measures, monitoring devices and life-support equipment. Clinical experiences are provided through a Capstone clinical. In order to progress in the Nursing Program, a grade of 75% or above must be achieved on all exams and a 75% or above must be attained on all course requirements. A grade of 90% or above must be attained on a dosage calculation exam in this course. Laboratory fee required. Prerequisites: NUR 230.
