COURSE DESCRIPTION: This course reviews the pathophysiology, assessment, and management of medical patients with neurological, environmental, genitourinary, obstetric and gynecologic emergencies, and behavioral emergencies. Total of 45 hours of lecture. Course fee required.

- Describe the characteristics of drugs used to affect the specific neurological, environmental, genitourinary, obstetrical and gynecological, and behavioral emergencies.
- Adapt the scene size-up, primary assessment, patient history, secondary assessment, and use of monitoring technology to meet the needs of patients with complaints and presentations related to specific neurological, environmental, genitourinary, obstetrical and gynecological, and behavioral emergencies.
- Describe the role of the Paramedic in the treatment and management of patients with specific neurological, environmental, genitourinary, obstetrical and gynecological, and behavioral emergencies.
