### **Board Briefing Summary**

President Klauber reviewed highlights in Academic Affairs, Workforce Solutions and Continuing Education, and College Advancement.

- Fall sports were closed down. It is hoped that spring sports can re-open.
- Employees are working on an AB schedule one week working on campus and the following week working from home for the month of January. It is expected that all will be back on campus beginning in February.
- Nursing and Allied Health students have been vaccinated. A survey was taken for employees interested in receiving the vaccine, and 287 were interested. This information was forwarded to the Washington County Health Department.
- University System of Maryland asked the Maryland community college to purchase transfer software; the presidents declined. MHEC has asked that each college track the credits that are denied for transfer within the USM system.
- The Solar Panel Parking Lot Project bids have been received.

# Financial Report as of December 31, 2020 (ACTION)

Mr. Snook moved to accept the financial report as of December 31, 2020. Ms. Cushwa seconded, and the motion carried by unanimous vote.

## **Enrollment Report**

Director Crawford said that total headcount was down 15.7%, and total FTE was down 18.2%. ESSENCE out-of-county and out-of-state were up. Some of St. Maria Goretti instructors have resigned, and HCC has picked up the slack for those courses. Admissions will reach out to recent graduates of WCPS. Mr. Snook moved to approve the Enrollment Report as submitted. Ms. Lampton seconded, and the motion carried by unanimous vote.

# **New Business**

## Policy 8005 - Governing Authority for Hagerstown Community College Police Department

Mr. Snook moved to approve the new policy as submitted. Ms. Cushwa seconded, and the motion carried by unanimous vote.

### **Citizen Participation**

HCC student athlete, Dharma Bhatt, asked to address the trustees regarding track and field. He said that all COVID measures have been taken and asked that track and field athletes be allowed to compete. Chair Williamson and President Klauber thanked Mr. Bhatt for his comments and assured him that all aspects regarding participation are carefully considered before decisions are made.
