Health Information Management



What do health information management professionals do?

Health information management (HIM) professionals, commonly referred to as health information technicians, organize and manage health information data. They ensure that the information maintains its quality, accuracy, accessibility, and security in both paper files and electronic systems. They use various classification systems, databases, and registries to organize and maintain data for clinical databases and registries, track patient outcomes for quality assessment and electronically record data for collection, storage, analysis, retrieval, and reporting.

What type of skills are needed to excel in this field?

Skills needed to work as an HIM professional include alertness, excellent attention to detail, manual dexterity, keyboarding skills, good organization, problem solving and analysis, and the ability to communicate in writing and verbally.

What types of jobs are health information management professionals able to obtain?

Job titles associated with health information management include HIM manager, HIM supervisor, Health Information Technologists, Medical Registrars electronic health records manager, clinical documentation improvement specialist, health information data analyst, medical coder/auditor, and clinical systems HIMS administrator.

Health information management professionals work in a variety of settings such as hospitals, ambulatory care, physician offices, rehabilitation centers, and health insurance companies, and focus on the quality of patient care, patient privacy compliance, information technology, and data quality.

Are there advancement opportunities for health information management professionals?

HIM professionals may advance to other health information positions by receiving additional education and certifications. Health information professionals may be able to advance to a position as a medical or health



services manager after completing a bachelor's or master's degree program. Requirements may vary by employment environment.

Is the Health Information Management program accredited?

- 2. College placement tests in mathematics, English and reading
- 3. Completion of MAT 095 and ENG 095, RDG 095, or satisfactory results on placement tests
- 4. A minimum cumulative grade point average for all college coursework of 2.0 on a 4.0 scale
- 5. Foreign education students must have their college and high school transcripts evaluated by World Education Services (WES)

How long does it take to complete the program?

Completion time depends on whether the student attends full or part-time. If the student attends full-time, the program can be completed in four semesters. This time frame is based on the student meeting all prerequisite standards.

Vaccine Requirements

Several immunizations are required as part of your health documentation, including: HEP B 3 vaccine series AND Positive immunity titer, Tetanus (Tdap) within last 10 years, Varicella 2 vaccine series AND positive immunity titer, MMR 2 vaccine series AND positive immunity titer, and the Flu vaccine (fall and spring), and the COVID-19 vaccine.

Since many individuals fail to maintain immunity over time, you may be required to repeat vaccination series/ receive a booster in order to demonstrate positive immunity. Positive immunity titers are required to proceed with Clinical or Externship rotations in all Health Sciences Programs. It is the student's responsibility to verify immunity prior to the start of the program and take the necessary steps to ensure positive immunity by the health documentation deadline provided to each cohort.

Other Requirements

An American Heart Association (AHA) Basic Life Support is required for healthcare providers (the AHA version is required for your licensure exams).
