## ACADEMIC PROGRAM MEMORANDUM OF AGREEMENT BETWEEN HAGERSTOWN COMMUNITY COLLEGE AND UNIVERSITY OF MARYLAND EASTERN SHORE REGARDING TRANSFER OF GENERAL EDUCATION AND INTRODUCTORY BUSINESS CREDITS TO BACHELOR OF SCIENCE IN HOSPITALITY AND TOURISM MANAGEMENT PROGRAM AT UNIVERSITY SYSTEM OF MARYLAND - HAGERSTOWN

This Memorandum of Agreement (MOA) is entered into by and between Hagerstown Community College (the "Sending Institution"), also referred to as "HCC," and the University of Maryland Eastern Shore (the "Receiving Institution"), also referred to as "UMES," (collectively, the "Institutions") to facilitate the transfer of general education and introductory business academic credits from HCC to UMES in order to support the completion of the Hospitality and Tourism Management Bachelor of Science Degree at the University System of Maryland (USMD) – Hagerstown Campus:

#### A. Qualifying Students

This agreement pertains to "Qualifying Students", i.e., those students who:

- Are currently accepted to the University of Maryland Eastern Shore's Hospitality and Tourism Management degree program at the USMD Hagerstown Campus and are seeking to complete their general education and introductory business requirement at HCC.
- Are currently University of Maryland Eastern Shore Hospitality and Tourism Management degree-seeking students at the USMD Hagerstown Campus wishing to complete their general education and introductory business requirement at HCC.

#### **B.** Responsibilities of the Institutions

The Institutions agree to implement the transfer of credits for Qualifying Students in accordance with applicable law and the following requirements and protocols:

 A Qualifying Student may transfer all general education courses and the introductory business course listed below from Hagerstown Community College to the University of Maryland Eastern Shore for the completion of the Bachelor of Science in Hotel and Tourism Management at UMES:

- The student must first apply to Hagerstown Community College as a non-degree seeking student (<u>https://www.hagerstowncc.edu/admissions</u>) and then register for the courses outlined above. UMES shall keep HCC apprised each semester (by week two) of students who are a part of this agreement.
- Once the student completes their required general education courses, HCC will send a paper transcript, free of charge, to UMES at the request of UMES, provided the student has authorized UMES to do so.

4. UMES shall designate, and shall provide to HCC, the contact information for a staff person at UMES who is responsible for the oversight of the transfer of Qualifying Students. HCC shall designate, and shall provide to UMES, the contact information for a staff person at the HCC who is responsible for the oversight of the transfer of Qualifying Students.

- If the Qualifying Student is using federal Title 38 VA Education Benefits (GI Bill® Education Benefits), the Institutions shall adhere to all applicable U.S. Department of Veterans Affairs' regulations, including the regulations governing the awarding prior credit, as regulated under Title 38, Code of Federal Regulations, Sections 21.4253(d)(3) and 21.4254(c)(4).
- Each Institution shall adhere to all applicable transfer requirements set forth in the Annotated Code of Maryland and the Code of Maryland Regulations.
- Each Institution shall advise students of financial aid opportunities and implications associated with the transfer of these aforementioned course credits.

- HCC will receive the FTE for all UMES students taking general education courses and the required introductory business course in support of the UMES Bachelor of Science Degree in Hospitality and Tourism Management.
- Should either Institution make changes to program requirements, the institution will inform the partner institution immediately. The memorandum of agreement should be updated to reflect the changes and forwarded to the Maryland Higher Education Commission.

### C. Term and Termination

- This agreement shall be effective on the date that it is signed by the appropriate and authorized representatives of each Institution.
- Either Institution may, at its sole discretion, terminate this Agreement upon delivering 30
  days written notice to the other Institution and the Maryland Higher Education Commission.
- 3. Both Institutions agree to meet once every 5 year(s) to review the terms of this agreement.

### D. Amendment

- This Agreement constitutes the entire understanding and agreement of the Institutions with respect to their rights and obligations in carrying out the terms of the Agreement, and supersedes any prior or contemporaneous agreements or understandings.
- This Agreement may be modified only by a written amendment executed by both Institutions.

## E. Governing Law

This Agreement shall be governed by, and construed in accordance with, the laws of the State of Maryland.

## F. Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.

#### G. Notice of Agreement

- The Institutions agree to provide a copy of this Agreement, with any amendments, to the Maryland Higher Education Commission.
- The Institutions agree to provide copies of this Agreement to all relevant individuals and departments of the Institutions, including but not limited to students, academic department

chairs participating in the transfer, offices of the president, registrar's offices, and financial aid offices.

#### H. No Third-Party Beneficiaries

There are no third-party beneficiaries to this Agreement.

#### I. Representations and Warranties of the Parties

Both Institutions represent and warrant that the following shall be true and correct as of the Effective Date of this Agreement, and shall continue to be true and correct during the term of this Agreement:

- 1. The Institutions are and shall remain in compliance with all applicable federal, state, and local statutes, laws, ordinances, and regulations relating to this Agreement, as amended from time to time.
- Each Institution has taken all actions necessary for the approval and execution of this Agreement.
