 - Single or double elimination bracket, depending on number of participants.
 - No inappropriate behavior or unsportsmanlike conduct
- Participants, including minors, are responsible for their own behavior and minors are to remain at the tournament site and not leave the building without parent/guardian consent.
- Nintendo is not a sponsor of or affiliated with this tournament. Ensure you are following Nintendo's terms for participating in and viewing Community Tournaments using Nintendo Games, including compliance with

Nintendo Account User Agreement and Community Guidelines, respecting other participants and staff, abiding by rules of the games, and not using unauthorized or otherwise modified software or tools.
