



# Hagerstown Community College Upward Bound Program 2025-26 Preliminary Application

Upward Bound is a grant funded college-prep program implemented collaboratively by Hagerstown Community College and Washington County Public School personnel. At no cost to the family, Upward Bound provides a variety of college related activities as well as academic support services to students year-round. All paperwork must be fully completed.



## **Program activities include:**

- Tutoring offered directly after school twice per week
- Saturday Session from 9am to 1pm offered once per month at HCC – workshops including financial aid and scholarship information, academic and career advising, college and career research, guest speakers and more
- Field trips and college campus tours throughout the year
- Opportunities to earn college credit prior to attending college (all tuition and fees are paid for by grant funding)
- Six-week summer academy on college campus opportunity
- Student service learning events
- Transportation to and from activities
- Breakfast and lunch provided at all activities

TRiO Upward Bound Program is a nationwide federally funded college-preparatory program that serves first generation college-bound high school students and/or students who reside in income-eligible households. Program benefits include individual academic tutoring, group and individual advising, field trips, college tours, career planning and guest speakers, Saturday workshops, and an annual summer academy.

The HCC Upward Bound program serves 72 students each year from four high schools in Washington County. Program eligibility is listed below.

- Must be a citizen of the United States or a permanent resident
- Must be either or both:
  - Meet federal income guidelines for TRiO programs

  - A first generation college student (the parents/guardians with whom the student lives has not earned a bachelor's degree)
- Must be a rising or current 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> grade student enrolled at one of the following schools:
  - North Hagerstown High School
  - South Hagerstown High School
  - Williamsport High School
  - Hancock Middle Senior High School
