Dean of Academic Innovation and Instructional Technology Update

- Professional Development Fridays Fall 2025 schedule
 - o Discussed priorities for attendance (required, optional, etc.)
 - o Sessions will be offered on Friday mornings throughout fall and spring
 - o Questions and feedback should be directed to Dean Beache or L. Cornwell
- IA Process Survey: Spring 2025 report
 - o Survey was distributed to all full-time faculty in Spring 2025
 - o Not much feedback provided, mostly positive comments about IA
 - o Should include adjuncts next time for a wider range of feedback
- D2L Process Changes supporting Inclusive Access (IA)
 - o Faculty should avoid using the combined course space if one course is cross-listed with another course that is not included in the IA program
 - o This does not apply to all IA cross-listed sections, and a reminder will go out to the divisions each semester regarding the impacted course sections
 - o WSCE does not use the IA program (VP Schoenenberger mentioned it may become required for cross-listed sections)
 - o A course preparation checklist widget (instructors only) and IA reminder widget (visible to all) will be added to each course home page in D2L
- Reminder for WCPS D2L Training
 - o Please remember to share names for basic vs. advanced D2L training sessions, so attendance can be tracked
 - O Dean Beache requested feedback on the minimum cutoff for combining sessions (e.g., less than 5 advanced attendees)
 - o Directors will share their list of required competencies
