



**FROSTBURG STATE UNIVERSITY MEMORANDUM OF UNDERSTANDING
BETWEEN**

FROSTBURG STATE UNIVERSITY

and

HAGERSTOWN COMMUNITY COLLEGE

regarding the

**BACHELOR OF SCIENCE
in Nursing**

Frostburg State University and Hagerstown Community College agree to offer a Bachelor of Science in nursing degree as an articulated program for students who are enrolled in the Associate Degree in Nursing program or have completed an Associate degree in Nursing and are pursuing a Bachelor of Science in Nursing.

Under these terms, students will be admitted to the RN-BSN program under the same standards as are all other students with a degree from any Maryland Community College. Frostburg State University will accept no more than 70 credits for the Associate degree earned.

This agreement applies to two different types of students that are eligible for enrollment in Frostburg State University's RN-BSN program and Hagerstown Community Colleges Associate Degree in Nursing program.

1. Students accepted to Hagerstown Community College's Associate Degree in Nursing program.
2. Students that have completed the Associate Degree in Nursing program at Hagerstown Community College, have an unencumbered RN license in the United States (or are qualified to complete their state RN licensure exam), and have completed the majority of prerequisite course work and general education requirements.

Note: Students in the Associate Degree in Nursing program at Hagerstown Community College may elect to pursue Frostburg State University's RN-BSN Program at any time. The student can then initiate the enrollment process and will be granted early admission to FSU's RN-BSN program as long as the student meets the admission requirements of the RN-BSN program and are in good standing in their second semester of nursing at Hagerstown Community College.

The student will receive dual advising from Hagerstown Community College and Frostburg State University faculty to guide the student in completing appropriate prerequisites and selecting first RN-BSN core courses. Advising sessions will be held every semester. This can be done via phone, email, or synchronous class per the student's choice.

All information related to registration, including course offerings and schedules of classes, will be made available at the community college site or via the Web for students enrolled at Frostburg State University. Any synchronous classes will be scheduled to accommodate the working adult while in an Associate Degree in Nursing program.

Student records will be maintained at Hagerstown Community College and will be made accessible to faculty and staff at Frostburg State University with written student permission on an as-needed basis.

Tuition and fees assessed will be that of Frostburg State University for all RN-BSN program core courses.

In the event the student decides to register for Frostburg State University RN-BSN courses while pursuing their Associate Degree in Nursing at Hagerstown Community College, they will be eligible to apply for Nursing Department and FSU Institutional scholarships.

Students can take any nursing course while pursuing their Associate Degree in Nursing provided they have completed all appropriate prerequisites as outlined in the Frostburg State University undergraduate catalog.

A chemistry course equivalent to Chemistry 100 Chemistry and Society or 201 General Chemistry I at Frostburg State University, or other approved four credit chemistry must be completed prior to admission or during the first semester of nursing classes.

Students that request orientation to the online learning environment may ask for a face-to-face orientation, an independent tutorial via the Web, or a synchronous class via synchronous classroom at any time during enrollment in the RN-BSN program. In addition, students may request a Q&A session regarding any course and/or program issues at any time during enrollment using the above-mentioned formats.

Attached is a description of the current programmatic and degree requirements. (*Note: Students must maintain a 2.0 cumulative grade point average in order to transfer.)

Overview and Summary

For students following this agreement, the steps are as follows:

Step 1: Complete the Associate Degree in Nursing at HCC.

Step 2: Apply for admission to Frostburg State University, indicating RN-BSN Program as the intended major. Applications for admission can be obtained by visiting the website:

The RN to BSN Program is based on the American Association of Colleges of Nursing's proposed *Essentials of Baccalaureate Nursing Education*. The program is approved by the Maryland Board of Nursing, the Maryland Higher Education Commission and the Commission on Collegiate Nursing Education (CCNE), and meets the requirements of collaboration among Frostburg State University (FSU), Maryland community colleges and other healthcare providers. Resources, facilities, and expertise are shared to allow the most efficient delivery of coursework and services and to match students with the most appropriate clinical placements.

The RN to BSN curriculum is designed to increase the registered nurse's knowledge and skills in the areas of leadership, quality improvement, evidence-based nursing practice, nursing informatics, population-focused health promotion and disease prevention, interdisciplinary collaboration, and professionalism. The program will prepare nurses to assume roles in leadership, complex clinical care coordination, and community/public health, and serves as the academic foundation for graduate study.

PROGRAM GOAL

The RN to BSN Program prepares the registered nurse to be a professional health care practitioner who provides compassionate care that is based on scientific evidence and who serves as the link between the patient (individual, family, community, or population) and the health care environment across the lifespan.

PROGRAM OBJECTIVES

The RN to BSN Program prepares the graduate to:

- Utilize critical thinking and creativity to address professional practice and patient care issues.
- Apply leadership concepts and collaborative strategies to the process of nursing care delivery.

- Utilize quality improvement and safety management principles in clinical nursing practice.
- Identify and understand basic elements of nursing research.
- Integrate scientific evidence with clinical judgment and patient preference to improve patient outcomes.
- Safely use information technology to improve patient care.
- Describe the ethical, legal, political, and financial influences on the delivery of patient care.
- Demonstrate interpersonal communication skills and collaborative strategies that support the delivery of interdisciplinary, patient-centered care.
- Provide evidence-based, preventative health care to families, communities, and vulnerable populations in community-based settings.
- Demonstrate the knowledge, skills, and attributes of professional nursing practice.

Summary of Requirements for Major in Nursing

General Education Program

Admission Requirements: *Unencumbered RN license in the United States or qualified to complete state licensure exam; *Official transcripts from all schools attended.

All candidates for the Bachelor of Science in Nursing degree must complete a minimum of 41 credits in general education. Courses may be completed at FSU or another institution (except as noted). The FSU course number is specified below. Where a specific course is listed, this is a required course for nursing that meets both major and GEP requirements. Please note that most of the required GEP courses must be completed before enrolling in upper-division nursing courses.
